
### **Electricity Sales**




#### Average Rate Per KWH Sold

### **Executive Report**



Kevin Heath is executive vice president and general manager of Albemarle EMC.

The past year has been one of change and achievement for Albemarle EMC. Former General Manager Gary Ray resigned his position at the cooperative to assume the position of chief executive officer for Jones-Onslow Electric Membership Corporation. After interviewing several highly qualified candidates, the Albemarle EMC Board of Directors chose myself to be the new general manager. I am both appreciative and humble to receive this opportunity.

Unfortunately, I have to report that former board director Glenn Carey Sr. passed away in January, after faithfully representing Camden County on the board of directors for 35 years. Glenn was a deep well of knowledge and experience, and we miss him dearly. The open Camden County seat will be filled at the co-op's Annual Meeting, on Sept. 21, and we look forward to welcoming the new board director.

We recently contracted with an independent consultanting firm to conduct a cost-of-service study to determine if our rates need to be adjusted. We should know the results of that study by the Annual Meeting.

For the 17th time in a row, Albemarle EMC earned its safety accreditation. Every three years, Albemarle EMC receives a surprise, comprehensive Rural Electric Safety Achievement Program inspection. The co-op earned high marks in every category.

Our charity golf tournament raised significant funds to purchase toys for about 500 children. The Albemarle Community Trust, voluntarily funded by members through their power bills, granted close to \$60,000 to local nonprofits that benefit our community. The co-op also was able to grant more than \$16,000 in Bright Ideas grants to local educators. These grants make innovative classroom projects possible that, otherwise, would lack funding. We were able to send two high school students to our Washington, D.C. Youth Tour as well as two middle school students to summer basketball camps. Co-op employees also participated in several school career days.

Albemarle EMC remained active in political advocacy on members' behalf. Meetings were held with state and federal legislators to stress the importance of affordable, reliable power.

In April, members received a total of \$648,287.04 in capital credits that were credited to members' bills. Capital credits are the year-end margins earned by your cooperative. They are allocated to each member based on their electricity usage for that particular year. Albemarle EMC is fortunate to have been able to make annual refunds to its members for as far back as records go.

Since being hired, I and senior management have prioritized optimizing our organizational structure to position the co-op for continued success. You have a talented, committed team working for you. It has been an honor and a privilege to serve you, and I look forward to another good year ahead.
